Possible Questions: What are the issues to be considered? For example, question may be raised around how to identify the interactions - e.g. Expert judgements, Interview, etc.?

- **Policy coherence tools**: What are the current examples of tools that can identify the interaction between SDGs targets (i.e. Nilsson, Griggs and Visbeck 2016)?
- **Process and Expert judgements**: After adopting a framework or tool (i.e. Nilsson, Griggs and Visbeck 2016), how do you ensure a legitimate process in identifying the interactions between the targets in selecting the critical nodes of interaction? (i.e. crowd sourcing used in GSDR reports, expert judgements)? Related to that, who should be identifying the interactions (i.e. scientists, policymakers and/or other stakeholders?)
- Scientific credibility: How do you ensure scientific credibility in identifying the interactions?

Possible Questions: What are the issues to be considered? For example, how to develop an institutional framework that would effectively address interaction of the SDGs in the given issue area? How to engage stakeholders at this stage?

- **Policy coherence**: What are the current examples of coordination mechanisms that can improve policy and institutional coherence?
- Institutional architecture: How would a multi-level governance architecture look like? Related to that, what is the role of the United Nations in general, and in particular, the High Level Political Forum in identifying and implementing interactions? What are the mechanisms beyond the states?
- **Orchestration:** What is the role of international organizations in orchestrating intermediaries that act or can act as critical actors for implementation?
- Science-Policy Interface: How do you secure interactions between science and policy actors at levels of implementation, i.e. national and local levels?
